As of July 1, 2024, Tallahassee Community College officially changed its name to Tallahassee State College. According to the school's website, this is the third name for the institution, opening as Tallahassee Junior College in 1966 and transitioning to Tallahassee Community College in 1970. Now 54 years later, college president, Dr. Jim Murdaugh, was quoted as saying, "The new name reflects who we are as an institution, better recognizing our institutional status and impact."

One facet of the institution is providing services to the Florida Department of Corrections. Vice-President of Workforce Development, Shelly Bell stated, "Tallahassee State College's partnership with the Department of Corrections is crucial to reducing recidivism rates by equipping inmates with the skills, knowledge and industry credentials to improve their employment prospects and help to ensure successful reintegration into society."


Current programs being offered through TSC at FDC facilities include:
